### 4.0 ANNUAL ACCOUNTS:

The Honorary Treasurer, Greg McCallum reported on the GIA accounts for 1 October 2016 to 30 September 2017.

The accounts are generally in a healthy condition. This year with a surplus of £3,528 compared to last year's £16,693. This is presumed to be due to unspent funds from festival totalling £8,000 these were returned to RIAS.

The Accountant, Robb Ferguson has advised that our accounts are all in order and comply with regulations.

The General assets fund has an increased surplus of £154,120 made up of £115,170 capital and £38,950 restricted funds.

The Alexander Thomson fund stands at £3204 and Student Awards fund £5279 further breakdowns of these can be found in the report issued prior to the meeting.

All the accounts are in a healthy condition including Architects Benevolent fund which did not have any withdrawals this year. If you are aware of anyone who is a suitable candidate, please contact the President or Secretary for further information.

Greg paid thanks to Robb Ferguson Accountants and Speirs and Jeffery for all their help and advice last year.
