2.0 Presentation of Resolutions

- 2.1 PZ presented the proposed resolutions and the background to the proposed constitutional reform, alongside a brief overview of the new Constitution.
- 2.2 ML enquired whether the GIA has an inventory of the assets to be transferred over. PZ responded that there is no inventory, but this has been flagged up by the GIA's lawyer that this is something required to put together, so the GIA Council will compile it and review it.

3.0 Resolutions

3.1 PZ Introduced Resolution 1:

To approve the Constitution of 'The Glasgow Institute of Architects' ('the SCIO'), subject to registration of the SCIO by the Office of the Scottish Charity Regulator ('OSCR'), together with any subsequent amendments as required by OSCR in order to secure registration of the SCIO as a Scottish Charitable Incorporated Organisation, and that The Council of the GIA now proceed to apply to OSCR for registration of the SCIO on behalf of the GIA.

Resolution accepted: 29 votes in favour, 0 against, 0 abstain

3.2 PZ Introduced Resolution 2:

Subject to passing the Resolution (1) above,

(i) To direct the Council of the GIA, following registration of the SCIO by OSCR, to proceed to transfer the assets, liabilities and undertakings of the GIA to the SCIO, and

(ii) Agree that the Council of he GIA proceed to dissolve the GIA at a suitable time thereafter

Resolution accepted: 29 votes in favour, 0 against, 0 abstain
